# **3** Additional Information

## 3.1 Restrictions

Known restrictions detected during internal testing – currently under analysis and to be followed up by Release Defect criticality assessments as stipulated in the T2 OGPF:

#### **Emergency Liquidity Transfers**

Emergency Liquidity Transfers can currently not be processed (affects only cash accounts, which shall be closed as of the next business day, but still have a balance).

#### **DWH Restrictions – Full scope Use Cases**

**PAR03:** PAR03 shows parties that are subject to MR in the second tab which shows parties that are "not" subject to MR as well, which they shouldn't.

**PAR04:** DWH PAR04 shows empty result after report generation

**IDC01:** IDC01 Report - ETL Issue The weighted average CL is incorrect. This is because the service downtime was not deduced in the "NO\_SECOND\_CREDITLINE\_SPAN" column in table TGDE042 **IDC02:** 

- IDC02 weighted IDC Use average, Minima, Maxima, Number of Events and Standard Deviation calculation of the hourly time intervals are incorrect

- IDC02 Specification Issue: the hourly time intervals were set statically.

- IDC02 The weighted average, Minima, Maxima, Number of Events and Standard Deviation calculation of the hourly time intervals are incorrect

- IDC02 - ETL Issue - Queued cash transfer orders does not display any data although queued cash transfer orders are available.

**CON01:** Report CON01 does not show output screen – server error occurs

**CON02:** Report CON02 does not show any data – empty output screen

**XML09:** CSLD XML09 XML parsing camt.011 RTGS user-defined report only shows bilateral limits, although multilateral limits exist. Multilateral limits are filtered out completely.

**XML10:** XML10: parsing camt.012 RTGS user-defined report only shows deletion of bilateral limits, although "delete all limits" exist. Delete all limits are filtered out completely.

#### 3.2 Regression Risk

The regression risk for this release is considered low according to regression tests performed in IAC and the analysis done by the support teams.
