**Reason for change and expected benefits/business motivation:**

It is currently possible creating Securities Valuations linked to a non-T2S Settlement Currencies. This behaviour should be prevented at Static Data validation level, in order to avoid, in case of mistakes by the T2S actors, loading massive data (i.e. valuations) that would not be usable for the auto-collateralisation process in T2S.

**Description of requested change:**

Modification of an already existing business rule (DSC3030) to prevent the creation of Securities Valuations linked to non-T2S Settlement Currencies.

Addition of rule in the specifications of the Valuations Loading files to prevent Securities Valuation data in non-T2S settlement currencies.

**Proposed wording for the Change request:**

Business rule DSC3030 shall be amended as follows: "When performing a Securities Valuation Create request, the Currency Code must refer to an existing instance in T2S defined as a T2S Settlement Currency."
